1. LEGAL FRAMEWORK

1.1 This MoU is a non-binding agreement that serves as a basis for collaboration between the Parties in the areas of academic exchange, faculty cooperation, research collaboration, and student development.

1.2 Both Parties shall ensure compliance with relevant laws, regulations, and guidelines issued by the University Grants Commission (UGC), affiliating university, and the Government of West Bengal. 1.3 This MoU does not create any legal rights or obligations enforceable in a court of law.

2. TERMS OF AGREEMENT

2.1 The Parties agree to collaborate in the following areas:

- Joint academic programs, seminars, and workshops.
- Faculty and student exchange programs.
- Research collaborations and resource sharing.
- Cultural and extracurricular activities.

2.2 Each Party shall appoint a liaison officer for effective coordination of activities under this MoU.

3. TERM AND EXPIRATION OF AGREEMENT

3.1 This MoU shall be valid for a period of **two (2) years** from the date of signing.

3.2 The MoU may be renewed upon mutual consent of both Parties through a written agreement.

3.3 Either Party may propose amendments to the MoU, subject to mutual agreement.

4. FREE TO EXIT

4.1 Either Party may terminate this MoU by providing a **three (3) months' written notice** to the other Party.

4.2 Termination shall not affect any ongoing projects or commitments made before the effective date of termination.

5. NON-FINANCIAL IMPLICATIONS

5.1 This MoU does not involve any financial obligations or liabilities for either Party.

5.2 Any costs incurred in implementing the objectives of this MoU shall be mutually discussed and agreed upon before execution.

6.2 This MoU does not restrict either Party from engaging in independent academic collaborations outside this agreement.

7. SPECIAL PROVISIONS

7.1 Both Parties shall promote equal opportunities and inclusivity in all collaborative activities.

7.2 Confidentiality of sensitive academic or administrative information shared under this MoU shall be maintained by both Parties.

7.3 Any intellectual property rights (IPR) arising out of joint research shall be decided on a case-by-case basis through a separate agreement.

7.4 Each Party shall obtain prior approval from the other Party before using the latter's name or logo for any activities under this MoU.


8. DISPUTE RESOLUTION


